





Analysis


The frequency of hate crimes against specific targets can reflect public policies, societal attitudes and national and international affairs. Thus, demographic changes, economic downturn, controversial legislation and other events may fuel bigotry and result in an increase in hate related activity.

 African Americans make up less than 2% of Orange County's population, but are consistently the most frequent targets of hate crime.

- Jewish and Muslims communities experienced dramatic increases last year, a doubling of hate crimes againt them in 2009.
- Hate crime trends against Latinos are down this year, ending a two-year upward trend.
- Hate crimes against the Gay and Lesbian community are down for a third year in a row.
- Hate crimes against some groups (e.g. members of the Gay and Lesbian community and undocumented immigrants) are under-reported due to fear and lack of trust.

Hate Crime (P.C. § 422.6)

A Hate Crime is a criminal act committed, in whole or in part, because of one or more of the following actual or perceived characteristics of the victim: Disability, Gender, Nationality, Race or Ethnicity, Religion, Sexual Orientation, association with a person or group of persons with one or more of the preceding actual or perceived characteristics. Under California law there are enhanced penalties for these types of crimes.



77 Hate Crimes Reported in 2009 in Orange County

- There was a 30% drop in the number of hate crimes targeting African-Americans. However, they remain the most frequent target of hate crimes.
- Hate crimes targeting Latinos took a dramatic drop, with less than half of the number reported last year.
 Six hate crimes is the lowest number reported since 2004.
- Hate crimes targeting Jews increased, dramatically for the second year in a row.
- While the number of hate crimes targeting the Asian Pacific Islander community is relatively low, there was a three-fold increase.
- Hate crimes against Muslim-Arabs rose at a higest rate since 2001.
- Hate Crimes targeting members of the Gay and Lesbian community continued a 3 year downward trend.


Methodology

This report provides a statistical overview on reported hate crimes and incidents that occurred in Orange County in 2009. There are a number of factors, elaborated below, that lead the Commission to conclude that the information contained in this report under represents the actual number of hate crimes.


The Commission carefully crosschecks each case to eliminate duplication. Due to this careful gathering of information, the Commission contends that this report is an accurate overall reflection of reported hate crimes in Orange County.

Some communities can suffer from under reporting due to a lack of knowledge about the justice system, cultural and language barriers, fear of reprisals, immigration status and a lack of confidence in government agencies.


The Commission urges caution when drawing conclusions on trends based on year-to-year variations of data.




There was an 50% increase in hate crimes targeting people, because of their religious beliefs, while crimes motivated by race or ethnicity declined 20%. Crimes labeled "multiple motivation" typically involve graffiti that targets more than one group.




National statistics show the overwhelming number of hate crimes are perpetrated by males. The large number of 'unknown' perpetrators primarily involves crimes against property.




More than half of the hate crimes reported in the Orange County targeted property. This was usually vandalism involving graffiti. Crimes targeting individuals were very similar in number to those of 2008.



Again, in 2009 there were notable and disturbing increases in crimes and incidents reported on school campuses, while hate related activities reported at businesses dropped considerably.





Orange County District Attorney



The following is a summary of hate crime cases handled by the District Attorney's Office:

- Thirty-Six cases were referred to the district attorney's office.
- Eight referred cases were rejected for filing.
- Nine cases referred as hate crimes were charged as other than a hate crime cases.
- Nineteen cases were filed as ha crimes.
 - Nine resulted in guilty pleas.
 - Two resulted in trial verdicts.

President Obama Signs a National Hate Crime Law

On October 28, 2009, President Obama signed the Matthew Shepard and James Byrd, Jr. Hate Crimes Prevention Act (HCPA), a law that makes it a federal crime to assault an individual because of his or her sexual orientation or gender identity.

The expanded federal hate crimes law was named for Matthew Shepard, a gay Wyoming teenager who died after being kidnapped and severely beaten in October 1998, and James Byrd Jr., an African-American man dragged to death in Texas the same year.



President Barack Obama hailed the hate crimes measure in the bill as a step toward change to "help protect our citizens from violence based on what they look like, who they love, how they pray."

Hate Crime Indicators

A hate crime indicator, sometimes called a hate or bias-motivated incident, is an action or behavior that is motivated by hate. but is protected by the 1st Amendment right to freedom of expression. The Constitution allows for hateful rhetoric as long as it does not interfere with the rights of others. Indicators include: name calling, hate epithets and the distribution or display of non-threatening racist or homophobic flyers or placards. Last year there were 49 cases of hate incidents. These included 34 harassment cases, 8 phone call cases, 4 mail/literature cases and 1 other case. OC Human Relations encourag-

es the reporting of such incidents because they reflect bias that may be addressed through education and/or dialogue.

The Hate Crime Indicators reported in 2009 are fairly typical of past years. African-Americans, and members of the Jewish faith are frequent targets of both hate crimes and bias-motivated incidents. The number of hate crimes and incidents reports targeting Muslims rose last year.
